<u>Rules</u>

General:

- Participants will be assigned a number for judging/voting purposes. Your chili will be displayed by Chili Name and Number.
- Participants will be given one cafeteria table, vinyl tablecloth, sampling cups, sampling spoons, and napkins.
- Participants must bring their own crock-pot with chili prepared/cooked at home.
- Participants are responsible for supplying all ingredients, serving utensils, and table decorations.







If desired, participants are also responsible for bringing their own sour cream, crackers, condiments, etc.

Set Up/Teardown:

- Participants will be allowed in the cafeteria at 4:00 PM
- All food must be handled with food safety gloves. These will be provided.
- Each contestant is responsible for policing and cleaning up the area at the end of the event and removing all items from the area. No items shall be allowed to remain after the close of the Cook-off.
- Participants are responsible for left over chili (if any).

<u>Chili</u>

- Chili may or may not contain meat. Chili may or may not contain beans. Chili may be red, brown, white, or any other color determined by recipe.
- Please provide enough chili to be served. It will be served in 1oz portioned cups.
- If chili is vegetarian, please indicate so with a sign or list of ingredients.

Judging/Awards

- Competition will be judged by a pre-selected CSCA Judging Panel.
- The Grand Prize winner will be determined on a 1-5 point scale based on the following criteria:
 - 1. Flavor "not too spicy or bland"
 - 2. Texture "not too chewy or mushy"
 - 3. Consistency "not too thick or too thin"
 - 4. Aroma
 - 5. Color
- The judges will also select a "Most Original" winner.
- The decisions of the judges, in their sole discretion shall be final and non-appealable.
- Chili Cook-Off patrons will select a "Fan Favorite" based on votes they cast.
